#### Additional Changes – August 31, 2011

##### ADD TO 96-110hp SPEC:

The undercarriage shall be designed and engineered by the tractor manufacturer. It shall be an extended life undercarriage with **Sealed And Lubricated Bushings** designed to withstand thousands of hours in highly abrasive soil. Successful bidder must provide the Forestry Commission with literature showing that the undercarriage is designed for maximum life and provide the necessary documentation showing that the entire undercarriage system has been tested to withstand thousands of hours in abrasive soil conditions.
